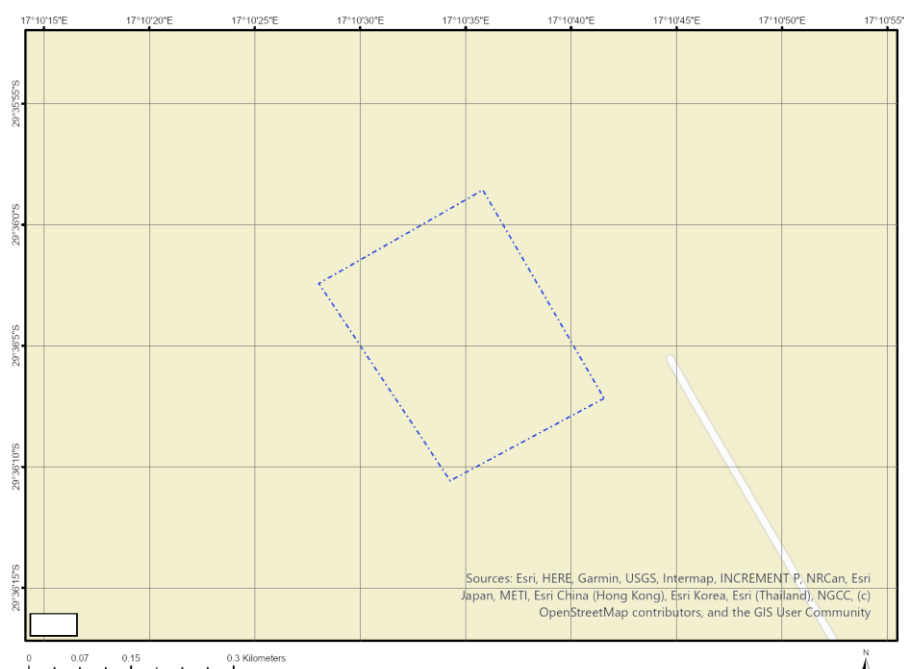

MAP OF RELATIVE AGRICULTURE THEME SENSITIVITY

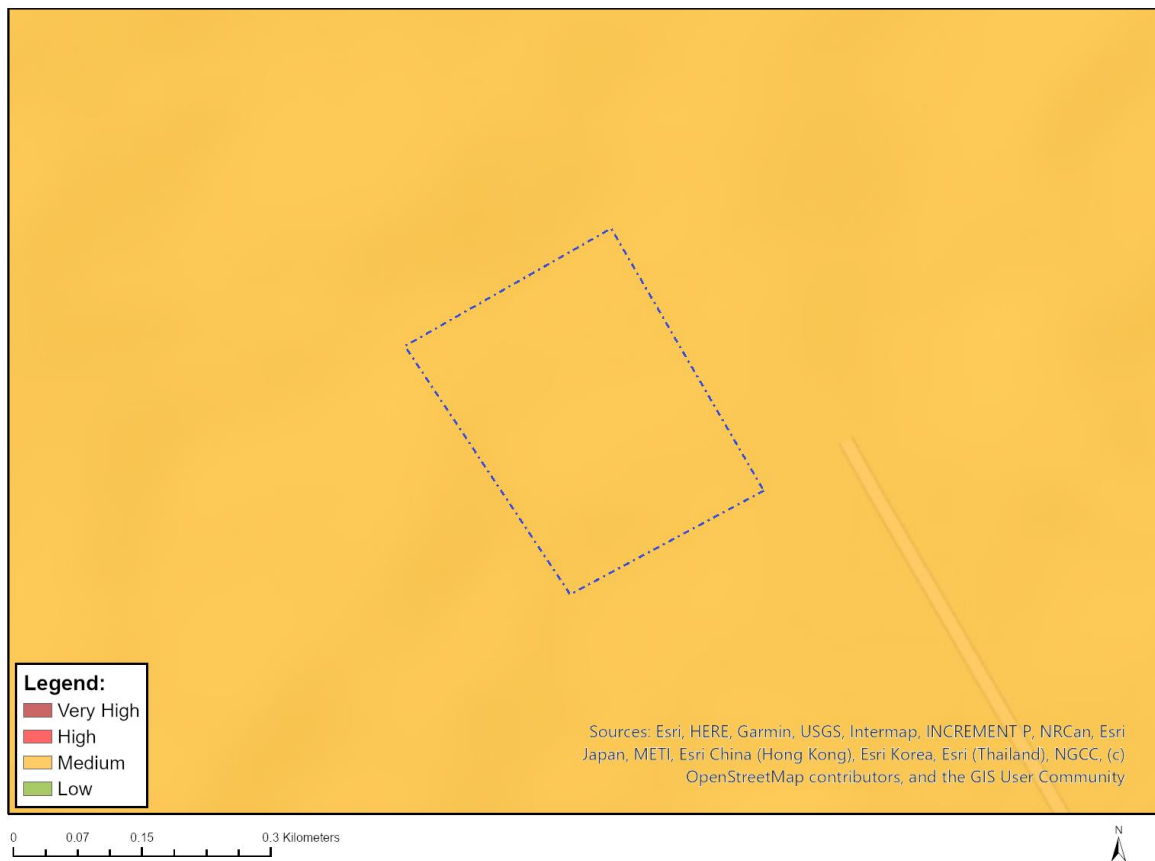

MAP OF RELATIVE AQUATIC BIODIVERSITY THEME SENSITIVITY

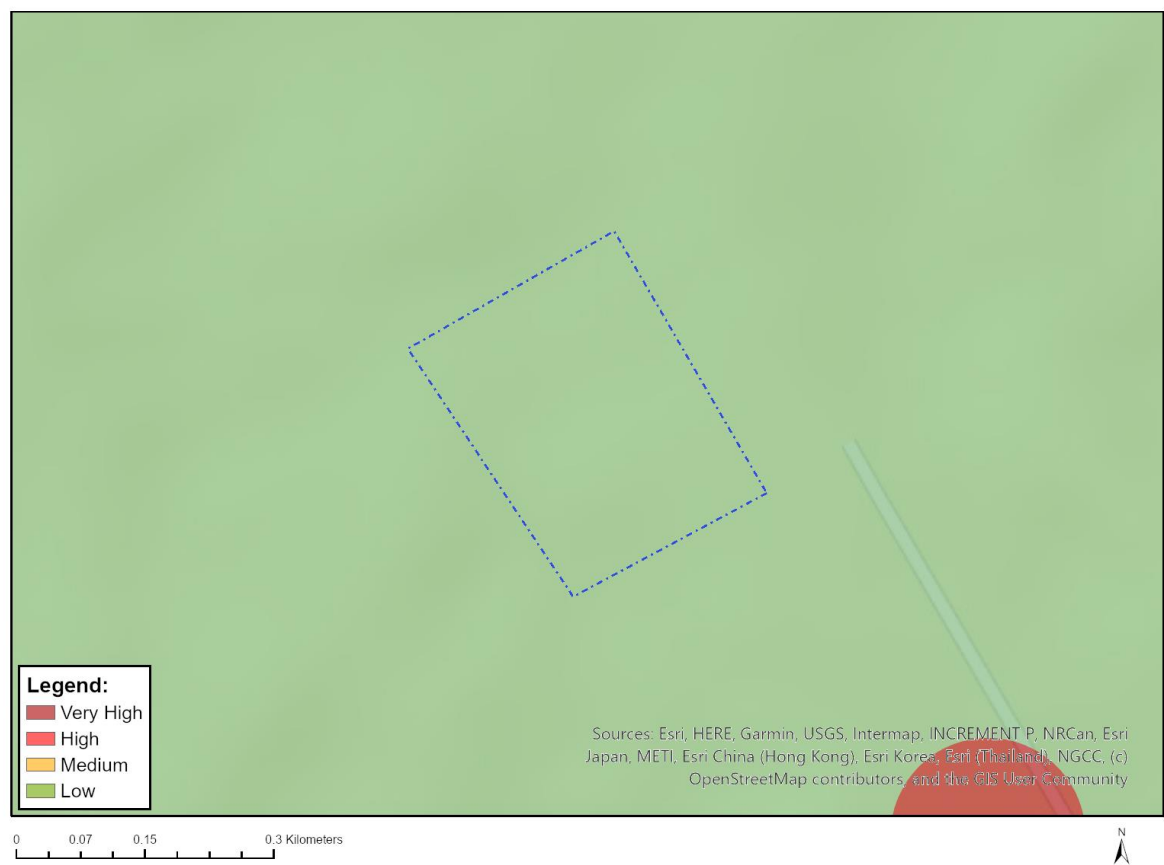

MAP OF RELATIVE ARCHAEOLOGICAL AND CULTURAL HERITAGE THEME SENSITIVITY

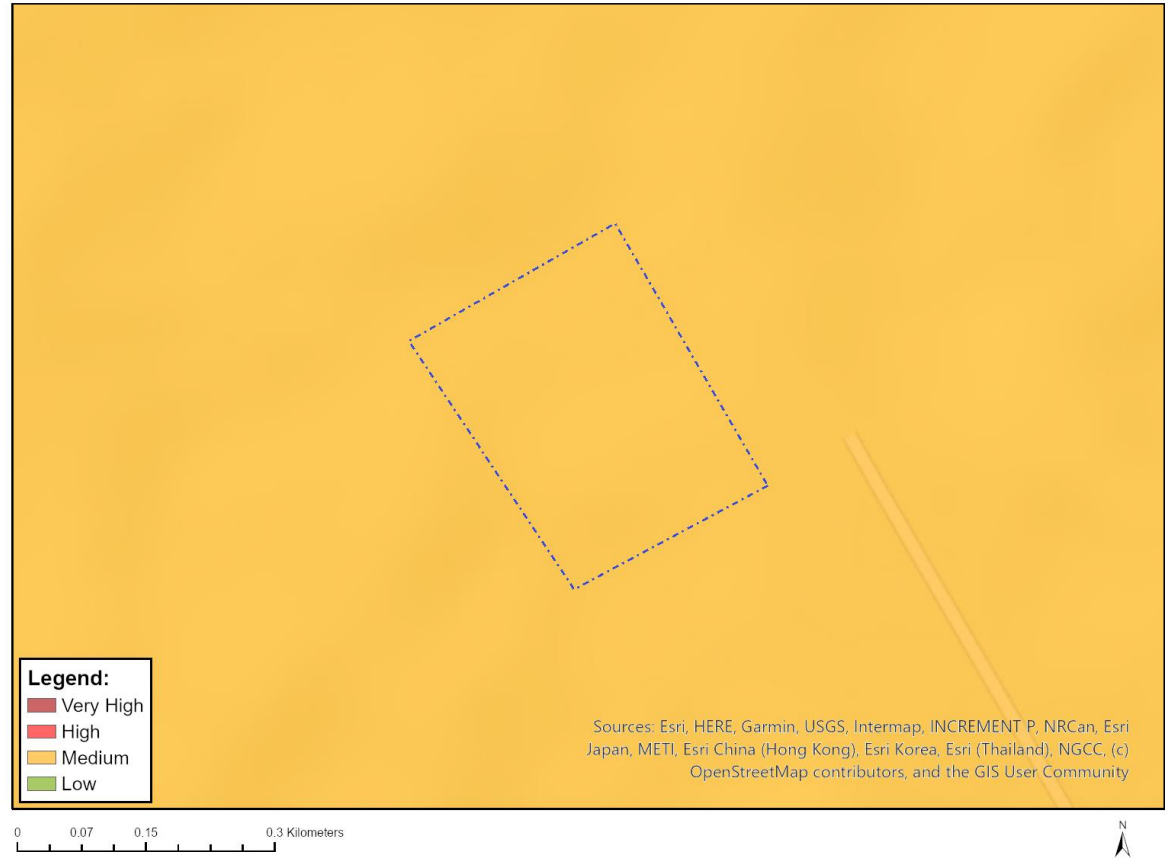
